She is currently under contract with UN Women as a member of the Advisory Committee for the Development of the National Care System of the Ministry of Equality and is a member of the National Participation Committee on behalf of "*Defendamos la Paz*" in the conversations between the Colombian Government and the *Ejército de Liberación Nacional* (ELN).

She was a member of the First and Seventh Commissions of the House of Representatives, Co-President of the Peace Commission, and a member of the Gender Equity Commission of such body.

She has served as an Advisor to the Office of the Dean of Universidad Pedagógica Nacional, on Peace and Gender Issues, as well as professor and researcher for its preschool education program. human development in the territories (Territorial Development) and vii) business strategy and/or project management.

As a member of Ecopetrol's Board of Directors, she is periodically trained in ethics, compliance and risk management matters.


