She is the Chairperson for the Board's Corporate Governance and Sustainability Committee and HSE Committee. She holds a bachelor's degree in Psychology and a Master's degree in Political Science and International Relations from the Pontificia Universidad Javeriana in Bogotá.

She is currently under contract with UN Women as a member of the Advisory Committee for the Development of the National Care System of the Ministry of Equality and is a member of the National Participation Committee on behalf of "Defendamos la Paz" in the conversations

between the National Government and the *Ejercito de Liberación Nacional* (ELN).

She was part of the Advisory Committee for the Development of the National Care System of the Ministry of Equality. She is a member of the National Participation Committee representing Defend Peace in the dialogues between the National Government and the ELN, and a member of the Gender Equity Commission of the same organization. Currently, she is part of the National Government delegation in the peace negotiations in the department of Nariño with the "Grupo Comunero del Sur"

She served as a Representative in the House of Representatives of the Republic of Colombia, participating in the First and Seventh Commission. She was also Co-Chair of the Peace Commission and a member of the Gender Equity Commission of the same government body.

She has been an Advisor to the Office of the Rector of Universidad Pedagógica Nacional, on Peace and Gender Issues, where she also worked as a professor and researcher in the Preschool Education Program. Furthermore, she served as Academic Dean of the School of Psychology of the Pontificia Universidad Javeriana, was a member of the Academic Board and the Board of Governors of this University and was a professor and researcher for the School of Psychology. She has also served as Cabinet Director of the Administrative Department for Social Welfare of the District Bogota under Antanas Mockus term as Mayor of Bogotá, and Policy and Project Social Director, Manager, and Coordinator in the fields of health, education, rural development, and the protection of young women's and children's rights for the Antonio Restrepo Barco Foundation.

Given her professional background, she has proven expertise in i) energy transition; ii) administration, senior management, and leadership; iii) government affairs and/or public policy; iv) business risk management; v) human resources and/or talent development; vi) health, safety and/or environment; vii) sustainability; viii) human development in the territories (Territorial Development) and ix) business strategy and/or project management.
