He holds an undergraduate degree in Law Universidad Cooperativa from Colombia in Barrancabermeja, as well as Specialization degrees in Labor Law and Social Security from the Universidad Libre de Colombia in Socorro. He has another specialization degree Constitutional Law, alongside a Master's degree in Law with a focus on Labor Law from Universidad Externado de Colombia Bogotá. Further enriching his expertise, he completed the

Specialization Course for Latin American Experts in Labor Relations at Universidad de Castilla-La Mancha, Spain.

Presently, he serves as Vice Minister of Labor Relations and Inspection at the Ministry of Labor.

He worked for Ecopetrol for approximately two decades, assumed the role of an arbitrator in legal disputes for the Company for more than 10 years, and his leadership within the Unión Sindical Obrera (USO) as the National Board Chair from 2018 to 2021 underscores his influential presence in the union labor domain.

Mr. Palma is also a professor at several universities in the country, particularly in the subjects of collective labour relations and labour human rights. Speaker, debater and columnist.


