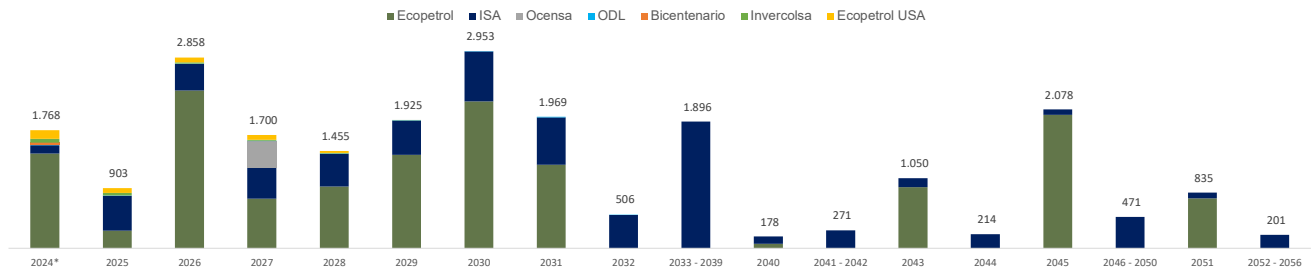

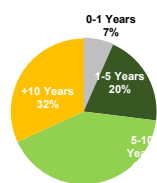
Maturity Profile by Type of Instrument (USD MM) - Ecopetrol Group - Does not include Intercompany Loans



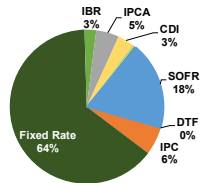

Debt Composition - Ecopetrol Group

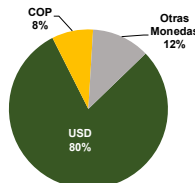
