



Esteban Piedrahíta Uribe (51) was a member of the Board of Directors of Ecopetrol S.A. since April 2019 until March 22<sup>nd</sup>, 2024. He was an independent member and Chairperson of the Board's Corporate Governance and Sustainability Committee until November 2023. As of such date, he became a non-independent member of the Board. He had also been a member of the Board of Directors from May 2009 to August 2010.

He holds a degree in Economics from Harvard University and a Master's degree in Philosophy

and History of Science from the London School of Economics and Political Science. He is the Dean of Icesi University.

He has held the positions of Chairperson of the Chamber of Commerce of Cali, General Director at Departamento Nacional de Planeación, Advisor to the President and then Senior Specialist at the Inter-American Development Bank, Economic Editor of Semana magazine, and General Manager of Endriven Colombia/Gas Meridional S.A.S. E.S.P., member of the Advisory Council of Fundación Panthera in Colombia, and member of the board of directors of Cementos Argos S.A., among others.

He is a member of the following boards of directors: Grupo Argos S.A. (only board of directors he holds a seat in from companies belonging to stock exchange markets – Bolsa de Valores de Colombia); Compañía de Seguros Bolívar S.A., and Seguros Comerciales Bolívar S.A. He is also a member of the Directive Council of Fundación Sidoc and Centro Internacional de Entrenamiento e Investigaciones Médicas (CIDEIM).

According to his professional background, he has experience in: i) the energy industry; ii) energy transition; iii) administration, senior management and

leadership; iv) government affairs and public policy; v) business strategy and project management; and vi) legal matters and/or corporate governance.

His experience in the energy industry, energy transition, and climate change and sustainability, refers mainly to his position as: i) manager of Endriven Colombia/Gas Meridional S.A.S. E.S.P., a company that operates mainly in the processing and commercialization of hydrocarbons, as well as biofuels; and, ii) independent member of the Investment Committee of MGM Sustainable Energy Fund (MSEF) I and II, which invest in non-conventional renewable energy and energy efficiency projects in Latin America.

In addition to the aforementioned positions, he has experience in finance and securities markets, having worked as Investment Banker with Salomon Brothers in New York and Estrategias Corporativas in Bogotá. As per technology and innovation matters, he founded two companies that specialize in the internet: Laciudad.com and Zoom Media Group, and participated in the Massachusetts Institute of Technology's (MIT) program "Digital Business Strategy: Harnessing Our Digital Future".

As a member of Ecopetrol's Board of Directors, he was periodically trained in ethics, compliance and risk management matters.
