



Ricardo Rodríguez Yee (49) has served as an Independent Member of the Board of Directors of Ecopetrol S.A. since March 2025. He also serves as Chair of the Audit and Risk Committee and Chair of the Business Committee.

He is an Industrial Engineer from Universidad Distrital Francisco José de Caldas and a Ph.D. candidate at the University of Palermo (Italy) in the program Model-Based Public Planning, Policy Design and Management. He holds Master's degrees in Organizational Management from Université du Québec à Chicoutimi and in Industrial Engineering from the University of the Andes.

He previously served as Delegate Comptroller for the Mining and Energy Sector and as Deputy Comptroller at the Office of the Comptroller General of the Republic, where he led fiscal investigations involving companies such as Reficar, Bioenergy, Propilco, Hidroituango, and Electricaribe.

He has also served as Director of the Mining and Energy Planning Unit (UPME), contributing to indicative planning and strategic development of the sector.

Mr. Rodríguez Yee led successful corporate restructurings in state-owned or state-participated companies, including Enertolima, Barranquilla Telecomunicaciones, Gecelca, Emsirva, and Cedelca. In addition, he has acted as an advisor on investment and strategy to the Chief of the General Staff of the National Army, the Commander General of the Military Forces of Colombia, the United Nations Development Programme (UNDP), the National Guarantee Fund (FNG), the Ministry of Mines and Energy, the Office of the Inspector General of the Nation, the National Federation of Departments, and Ecopetrol.

Based on the positions held throughout his professional career, Mr. Rodríguez Yee has experience in: (i) the energy industry; (ii) energy transition; (iii) administration, senior management, and leadership; (iv) government and public policy matters; (v) financial matters; (vi) enterprise risk management; (vii) human resources and talent

development; (viii) legal and corporate governance matters; (ix) technology and innovation; (x) health, safety, and environmental matters; (xi) sustainability; and (xii) business strategy and project management.


