



Gonzalo Hernández Jiménez (45) is a member of Ecopetrol's Board of Directors since October 2022. He was а nonindependent member until April 30, 2024, and as of May 1st, 2024 he is an independent member. He holds a Ph.D. in Economics from the University of Massachusetts and is an Economist from the Pontificia Universidad Javeriana. He is a current professor of Javeriana's department Universidad of economics.

He was Technical Vice Minister of Finance and Public Credit, and a member of the Board of Directors of Bicentenario S.A.S., and the

Administrator of Resources of the General System of Social Security in Health (ADRES, for its Spanish acronym). He has held the position of director of the Economy and Research Department at Universidad Javeriana. Currently, he is a member of the Board of Directors of Financiera de Desarrollo Nacional (FDN), and of the Aris Mining Corporation, located in Canada.

Given his professional background, he has expertise in: i) administration, senior management and leadership; ii) financial and securities markets; iii) human resources and talent development; iv) legal matters and/or corporate governance; v) business strategy and project management; vi) health, safety and/or environment; and vii) sustainability.

In addition to the previously mentioned positions, he has experience in: i) the energy industry, with the publication "Oil and Regime Type In Latin America: Reversing the Line of Causality. Energy Policy", and in ii) government affairs and public policy, due to his studies and academic publications in the Cambridge Journal of Economics, Energy Policy, International Review of Applied Economics and Cepal Review, featuring among these, the following: "Terms of trade shocks and taxation in developing countries", "Output comovement between Latin America and the United States: the export structure matters", "On the structural tax reform that is needed in Colombia" ["*Sobre la reforma tributaria estructural que se requiere en Colombia*"], "Latin America after the global crisis: the role of export-led and tradable-led growth regimes", "Terms of trade and output fluctuations in Colombia ".

As a member of Ecopetrol's Board of Directors, he is periodically trained in ethics, compliance and risk management matters.
