Has extensive professional experience, having occupied the following positions in the public sector: Minister of Education of Colombia, Secretary of Education of Bogota, Minister Counselor for Economic Affairs at the Embassy of Colombia in the United Kingdom, Deputy Director and Head of the Territorial Development Unit at the National Planning Department, Head of Planning of the Urban Development Fund at Banco Central Hipotecario, and Deputy Director of Planning at Banco de la República (National Central Bank). She has served as Rector of Universidad Jorge Tadeo Lozano and was Visiting Professor at the Graduate School of Education at the same University.

She is currently a member of several Boards of Directors and Advisory Boards, including: Suramericana de Seguros, Fedesarrollo, Fundación Luker, United Way, Empresarios por la Educación and Fundación Alejandro Angel Escobar. She assists on the Advisory Board of the Harvard Ministerial Leadership Program and provides advisory and consulting services.

The Director has experience in the energy industry, having served as Private Secretary in the Ministry of Mines and Energy and through her participation in preparing the 1982 National Energy Plan. 
