



**Juan José Echavarría (71)** is an independent member of Ecopetrol's Board of Directors, nominated by the Minority Shareholders with Largest Shareholding since March 2023. He is the Chairperson of the Board's Corporate Governance and Sustainability Committee since November 2023.

He is an Administrator Engineer from the School of Mines, Universidad Nacional de Colombia and completed a non-degree program in Economics at Harvard University. He holds a Master's Degree in economics from Boston University and a PhD

in Economics from Oxford University. He had served as a member of the Board of Directors of Ecopetrol for four months in 2016.

He is currently an Associate Researcher at Fedesarrollo and a dedicated University professor.

He previously served as General Manager and Board Director of the nation's central bank (Banco de la República), as a Consultant of the Development Bank of Latin America (CAF), the Inter-American Development Bank (IDB), the Ministry of Commerce and Finagro, Director of the Mission for the Restructuring of Coffee in Colombia, Executive Director of Fedesarrollo, Plenipotentiary Minister of the Colombian Mission to the Organization of American States (OAS), advisor in the area of International Trade at the OAS, Vice Minister of Foreign Trade of Colombia and principal negotiator of the Colombia- Chile Colombian- Central America, Colombia - Caricom, and Colombia - G3 trade agreements, and dean of the Faculty of Economics of the Universidad Nacional de Bogota.

He has served on the Boards of Directors of Isagen S.A., Banco de la República, Bolsa y Banca, and Fiduciaria Bogotá. He is currently a member of the Board

of Directors of the not-for-profit Alejandro Angel Escobar Foundation.

Given his professional background, he has experience in: i) the energy industry, mainly acquired from his role as an Associate Researcher in energy and oil and gas topics, amongst others, for Fedesarrollo, a Colombian independent center for social and economic research; ii) administration, senior management, and leadership; iii) government affairs and/or public policy; iv) financial and securities market; v) human resources and talent development; and vi) legal affairs and corporate governance.

As a member of Ecopetrol's Board of Directors, he is periodically trained in ethics, compliance and risk management matters.

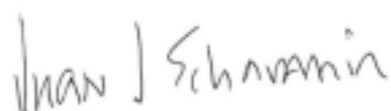
