He holds a bachelor's degree in Law from Universidad Cooperativa de Colombia in Barrancabermeja, as well as graduate degrees in Labor Law and Social Security from the Universidad Libre de Colombia in Socorro. He also holds a graduate degree in Constitutional Law and a Master's degree in Law with a focus Labor Law. both on Universidad Externado de Colombia in Bogotá. He also completed Specialization Course for Latin American

Experts in Labor Relations at Universidad de Castilla-La Mancha, Spain.

He currently serves as Vice Minister of Labor Relations and Inspection at the Ministry of Labor. He worked for Ecopetrol for approximately two decades, served as an arbitrator in legal disputes for the Company for more than 10 years, and led the *Unión Sindical Obrera* (USO) as the National Board Chair from 2018 to 2021.

Mr. Palma is also a professor at several universities in the country, particularly in the subjects of collective labor relations and labor human rights. Speaker, debater and columnist.

Given his professional background, he has proven expertise in i) administration, senior management, and leadership; ii) governance and/or public policy; iii) human resources and/or talent development; iv) legal matters and/or corporate governance; and vi) health, safety and/or environment.


